- b) Basic qualification certificates as below
 - For A Class Registration: 10+2 pass certificate + Bachelor of Acupuncture (or)Master of Acupuncture Certificates.

- For B Class Registration: 10+2 pass certificate + Diploma in Acupuncture Certificate.
- c) Demand Draft for prescribed fee amount drawn in favour of "F A S T Board" payable at Bangalore.

- 1. Diploma/ Bachelor/ Postgraduate Certificate holders of the FAST Board.
- 2. Diploma/Degree holders of any authentic institution.

Benefits: As per Rule 7A of FAST Board, the Registered Practitioner would be declared a person qualified to practice and shall not be convicted on Government in India.

Minimum Age: Applications for registration who are not Certificate holders of FAST Board should be a minimum of 21.

Requirements:

Students are required to submit the following for Registration:

- 1. Registration Application form as enclosed.
- 2. Three passport size photographs.
- 3. One Experience Certificate of a minimum of 5 years from a Registered Doctor/MLA/MP/Sarpanch/Gazetted Officer OR a Xerox copy of Bachelor/Postgraduate Certificate awarded by the Federation of Acupuncture system of Therapy Board or any authentic Institution.
- 4. Fees in the mode of Demand Draft/cheque/M.O.(The Bank Draft/Cheque should be payable to FAST Board.

All Documents, application form and fees should be submitted to Federation of Acupuncture system of Therapy Board, Bangalore.

You will get the following documents within 40 days from the date of receipt of the form and fees:

- 1. The registration Certificate duly affixed with the Special Adhesive Stamp as per the order of the concerned authority.
- 2. Identity Card.
- 3. Copy of the Rules of the FAST Board under which Registration is issued.
- 4. Copy of the Code of Conduct.

Fees: Rs.6,000/- (Rupees Six Thousand only)

Registered Acupuncture Practitioner (R.A.P.) Certificate validity for period of 10 years. Further renewal should be taken place with their certificates & prescribed fee.

Classification of Membership:

- a) The board will issue the Fellowship / Membership only on the Merits of the Acupuncture Health Society. After obtaining a Fellowship/Membership his/her name can prefix the FAHS or MAHS.
- b) All above Members and R.A.P. are not entitled to the governing council elections.
- c) To obtain a Fellowship of Acupuncture Health Society (FAHS) INR 4,500. In Favor of FAST Board Payable at Bangalore.
- d) To obtain a Membership of Acupuncture Health Society (MAHS) INR 4,000. In Favor of FAST Board Payable at Bangalore.
