Admission

Federation of Acupuncture System of Therapy Board offers two types of admission for the convenience of the student.

- 1. Academic Year Training June December Cycle
- 2. Calendar Year Training January to May

Admission Procedures:

Download your admission form online **www.fastb.ac.in**. Ensure you have read through the prospectus fully. Duly fill the admission form neatly in Capital Letters. No column should be blank; Your name and communication address to be stated clearly.

List of documents to be submitted at time of admission :

- Original passing certificate of 10th and 12th / Graduation for Verification only.
- One self attested Certificates.
- 5.Passport Size Photos with name and course name written on the back of each photo.
- Application form issued by Board / Study Centre with Fees.
- For NRI student Passport copy with R.P.
- Payment as Demand Draft/Cheque/Cash/Online.

The verified documents reach the board from various study centers and upon satisfaction and receipt of payment, the board to issue enrollment number and ID cards completing the admission procedure.

Examination

The Board to hold examinations at study center or other premises near to students to aid them in easy accessibility based on number of students appearing for the exams.

Examinations will be held both as theory and practical coupled with internal assessments for overall growth and development.

Theory examination paper structure consists of 3 parts for a total of 70 marks - Part 1 to be compulsory objectives of 15 marks; with Part 2 and 3 to be multiple choice answers for 25 marks and 30 marks respectively (OR) it may changes timely.

Practical Examinations includes Half hour oral, viva, and Applications of Self Needling and on Screen Quiz based on all practical conducted in that year.

Internal Assignments are to be submitted according to the prescribed schedule before the term- end examination. In case, the student has not submitted the assignment within the prescribed date, the result of such candidate will be declared on the basis of the theory marks only. The Assignments are applicable for master level trainers.

Board Membership Registration
